# NEW FUNDS FOR HOME ENERGY IMPROVEMENT

### TAX CREDITS: AVAILABLE NOW

Tax credits reduce your tax bill dollar for dollar during the year that you made the installation. These tax credits only apply if someone pays federal income taxes (for example, by paying into income tax throughout the year). Most tax credits for home energy upgrades offer up to 30% refund on eligible items. Limits apply, so check the details before making purchases.

#### There are thousands of dollars of tax credits for households available now for:

- Insulation
- Windows
- Doors
- Home energy audit
- Electrical panel upgrade
- High efficiency HVAC
- On-site solar panels and battery storage

### **REBATES: COMING SOON**

Upfront rebates will be available for making homes more comfortable and energy efficient and improving indoor air quality. Some rebates will be prioritized for households with low and moderate incomes. The rebate program will be administered by the State Energy Offices (SEOs). SEOs have until August 16, 2024 to apply to receive the funding for the programs.

\*NOTE that the final rules for this program are still in development. We will continue to update materials and inform you as new information is available.\*

#### Home Energy Performance-Based Whole House Rebate (HOMES) Program:

- For all households
- Rebates for energy-saving retrofits
- Rebate amounts increase for low-income households (up to 80% area median income)
- Up to \$4,000 per household, or \$8,000 for low- to moderate-income households
- Also available for multi-family housing

#### High-Efficiency Electric Home Rebate Program:

- For converting from gas or propane appliances to electric
- Exclusively for low- to moderate-income (LMI) households (up to 150% area median income)
- Efficient electric appliances, including heat pumps, heat pump water heaters, and electric stoves or ovens
- Includes improvements to electric panels and wiring, and home insulation
- Up to \$14,000 per household
- Expected to be available for single and multi-family houses
