



## Knoxvillians feel the burden of energy costs.

Low-Income Energy Burden by Census Tract



Energy Burden

Portion of income spent on energy

High Energy Burdens are 6% or higher.

#### Energy Burden

Low-income energy burdens can be over 18% in East Knoxville. KUB has more power than they are using.

Other forums address the income side of the energy burden equation, but energy cost remains a problem.

City Council to vote on climate goals August 13.

City government goal: 50% from 2005 levels by 2030.

Community-wide goal: 80% from 2005 levels by 2050.






#### Knoxville Climate Goals


### TVA energy efficiency investment and savings are declining.

#### Public Power

The Knoxville-TVA relationship is complex. TVA is an area employer. KUB must buy all power from TVA. KUB is one of TVA's largest customers. TVA has cut energy efficiency funding and limits customer access to solar.

#### Knoxvillians want more solar!






#### Clean Energy

Austin, TX

Net zero by 2050

Houston, TX

Carbon neutral by 2050

New Orleans, LA

community-wide 50% by 2030

Atlanta, GA

40% from 2009 baseline by 2030 Asheville, NC

2% reduction per year until 80% below 2008 levels

Miami, FL

25% from 2006 baseline by 2020

Will increase to \$20.50 for electric in November 2019.




#### KUB is a public power entity.

The KUB Board of Directors regulates KUB on behalf of KUB customers and Knoxville residents.

KUB Board meetings provide customers 5 minutes to speak directly to the Board.

The KUB Board meets monthly at noon on a Thursday downtown.
