Note 1: Simplifying assumptions were made regarding assets placed in-service for the purposes of calculating these estimates. Base Rate estimates were calculated for the year following the date the assets were placed in-service for items going in service in December of a given year. The 2021 impact is estimated to be an increase of \$11.45 in January and \$17.25 beginning July.

Note 2: This line shows the estimated rate impact of fuel savings due to having LNP vs. an all natural gas portfolio.

Note 3: The revenue requirements for the NCRC Rate presented above reflect the Rate Management Plan as proposed in Docket 100009-El.

Note 4: Retail sales were obtained from the January 2010 sales forecast – 20 year weather normalization.
